Foreign Financial Account Reporting (FBAR, FinCEN114, FATCA, Form 8938)
FBAR Requirements: US taxpayers with foreign accounts exceeding \$10,000 must file an
FBAR with FinCEN by April 15th (automatic extension to October 15th).
FATCA Requirements: US taxpayers with foreign financial assets must report on Form 8938
with their tax return, with thresholds varying by filing status and residency.
